PREGNANCY, FOSTER CARE, AND ADOPTION SERVICES: THE AGENCY PROVIDES CASE MANAGEMENT, COUNSELING, REFERRALS AND SUPPORT TO ASSIST WOMEN COPING WITH AN UNPLANNED OR CRISIS PREGNANCY. THERE WERE 1,401 PREGNANT AND PARENTING WOMEN AND FAMILY MEMBERS SERVED AND 189 BABIES BORN. ADOPTION SERVICES PLACED 35 CHILDREN DOMESTICALLY AND ASSISTED IN 14 INTER-COUNTRY PLACEMENTS, DEVELOPED 53 GUARDIANSHIP PLANS AND PRESENTED 20 PARENT EDUCATION WORKSHOPS. RESPITE AND FOSTER CARE SERVICES WERE OFFERED FOR 194 CHILDREN. FOSTER CARE CASE MANAGEMENT SERVED 96 CHILDREN.

SCHOOL COUNSELING: THE PROGRAM IS FUNDED BY THE ST LOUIS COUNTY CHILDREN'S SERVICES FUND AND PROVIDED SERVICES IN SCHOOLS IN ST LOUIS COUNTY. THE AGENCY RUNS A SCHOOL-BASED COUNSELING PROGRAM DESIGNED TO ADDRESS THE EMOTIONAL, BEHAVIORAL, AND MENTAL NEEDS FOR CHILDREN AGES 3 TO 19. 78% OF CHILDREN DEMONSTRATED A DECREASE IN SYMPTOMS OR MAINTAINED THEIR LEVEL OF PSYCHOSOCIAL FUNCTIONING. THE PROGRAM SERVED 2,192 DIRECT CLIENTS. 26,190 HOURS OF INDIVIDUAL COUNSELING WERE PROVIDED.
