PREGNANCY, FOSTER CARE, AND ADOPTION SERVICES: THE AGENCY PROVIDES CASE MANAGEMENT, COUNSELING, REFERRALS AND SUPPORT TO ASSIST WOMEN COPING WITH AN UNPLANNED OR CRISIS PREGNANCY. THERE WERE 1,207 PREGNANT AND PARENTING WOMEN AND FAMILY MEMBERS SERVED AND 170 BABIES BORN. ADOPTION SERVICES PLACED 31 CHILDREN DOMESTICALLY AND ASSISTED IN 15 INTER-COUNTRY PLACEMENTS, DEVELOPED 57 GUARDIANSHIP PLANS AND PRESENTED 20 PARENT EDUCATION WORKSHOPS. RESPITE AND FOSTER CARE SERVICES WERE OFFERED FOR 38 CHILDREN. FOSTER CARE CASE MANAGEMENT SERVED 138 CHILDREN.

THE AGENCY RUNS A SCHOOL-BASED COUNSELING PROGRAM DESIGNED TO ADDRESS THE EMOTIONAL, BEHAVIORAL, AND MENTAL NEEDS FOR CHILDREN AGES 3 TO 19. 78% OF CHILDREN DEMONSTRATED A DECREASE IN SYMPTOMS OR MAINTAINED THEIR LEVEL OF PSYCHOSOCIAL FUNCTIONING. THE PROGRAM SERVED 2,191 DIRECT CLIENTS. 23,186 HOURS OF INDIVIDUAL COUNSELING WERE PROVIDED.
