FAMILY SERVICES: THE AGENCY PROVIDES FAMILY SERVICES INCLUDING PREGNANCY, PARENTING, ADOPTION, AND FOSTER CARE SERVICES. PREGNANCY AND PARENTING SERVICES PROVIDE CASE MANAGEMENT, COUNSELING, REFERRALS, AND SUPPORT TO ASSIST WOMEN COPING WITH AN UNPLANNED OR C.RISIS PREGNANCY. IN 2017, THERE WERE 584 PREGNANT AND PARENTING WOMEN AND FAMILY MEMBERS SERVED AND 368 BABIES BORN. ADOPTION SERVICES PLACED 64 CHILDREN IN 1017 AND DEVELOPED 20 GUARDIANSHIP PLANS. RESPITE AND FOSTER CARE SERVICES WERE OFFERED FOR 36 CHILDREN WITH A TOTAL OF 561 DAYS. FOSTER CARE CASE MANAGEMENT SERVED 128 CHILDREN.

LFCS UTILIZES EVIDENCE-BASED PRACTICES TO ADDRESS MENTAL HEALTH NEEDS WITH A GOAL OF DECREASING SYMPTOMS. IN 2017, STAFF PROVIDED 14,101 COUNSELING SESSIONS. 407 ADULT AND 899 CHILDREN WERE SERVED IN THE COUNSELING PROGRAM.

THESE SERVICES ARE FUNDED BY THE ST. LOUIS COUNTY CHILDREN'S SERVICES FUND. IN 2017, THE PROGRAM SERVED 1,885 CHILDREN AND PROVIDED 17,752 HOURS OF INDIVIDUAL COUNSELING. 85% OF CHILDREN DEMONSTRATED A DECREASE IN SYMPTOMS OR MAINTAINED THEIR LEVEL OF PSYCHOSOCIAL FUNCTIONING.
