FAMILY SERVICES: THE AGENCY PROVIDES FAMILY SERVICES INCLUDING PREGNANCY, PARENTING, ADOPTION, AND FOSTER CARE SERVICES. PREGNANCY AND PARENTING SERVICES PROVIDE CASE MANAGEMENT, COUNSELING, REFERRALS, AND SUPPORT TO ASSIST WOMEN COPING WITH AN UNPLANNED OR CRISIS PREGNANCY. IN 2019, THIS PROGRAM SERVED 803 PREGNANT AND PARENTING WOMEN. THE AGENCY PLACED CHILDREN WITH 42 ADOPTIVE FAMILIES. EMERGENCY RESPITE CARE WAS PROVIDED FOR 46 CHILDREN WITH A TOTAL OF 563 DAYS OF CARE.

BEHAVIORAL HEALTH: OUTPATIENT COUNSELING SERVICES AND PSYCHIATRIC SERVICES ARE OFFERED TO ADULTS, CHILDREN, AND FAMILIES. INDIVIDUAL AND GROUP SESSIONS ARE AVAILABLE. LFCS UTILIZES EVIDENCE-BASED PRACTICES TO ADDRESS MENTAL HEALTH NEEDS WITH A GOAL OF DECREASING SYMPTOMS. IN 2019, ADULTS AND CHILDREN RECEIVED COUNSELING SERVICES, AND 132 CHILDREN RECEIVED PSYCHIATRY SERVICES. IN ADDITION, THE AGENCY RUNS A SCHOOL-BASED COUNSELING PROGRAM DESIGNED TO ADDRESS THE EMOTIONAL, BEHAVIORAL, AND MENTAL HEALTH NEEDS FOR CHILDREN AGES 3 TO 19. THESE SERVICES ARE FUNDED BY THE ST. LOUIS COUNTY CHILDREN'S SERVICES FUND. IN 2019, THE PROGRAM SERVED 1,269 CHILDREN IN SCHOOLS AND PROVIDED 12,067 HOURS OF INDIVIDUAL COUNSELING.
